Bidding documents may be purchased from the office of Budhiganga Rural Municipality, Morang by eligible bidders, on submission of a written application and upon payment of a non-refundable fee for bid documents as mentioned in the following table, until the office hour of **9 May, 2019 (2076/01/26)**. Bidders who choose to submit their bid electronically through e-GP portal of Public Procurement Monitoring Office (PPMO), web Site <http://www.bolpatra.gov.np>, the Bidders may either purchase the hard copy of bidding documents or may choose to download the necessary part of bidding documents, prepare their bids and submit their electronic bids as specified in the Instructions to Bidders. In case the Bidder chooses to download and submit bid electronically, the Bidder shall be required to deposit the cost of bidding document in the BGRM's Rajaswa (revenue) account 69CA501175524001 (NIC Asia, Biratnagar Branch) either by direct deposit or by tele-transfer of deposit in the BGRM account for the purchase the bids as specified below and electronic scanned copy (PDF format) of the Bank deposit voucher or Tele-transfer certificate shall also be submitted along with the electronic bid files.

5. Bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 on **May 10, 2019 (2076/01/27)** at the office of Budhiganga Rural Municipality, Morang.
6. Bids must be valid up to **Aug 8, 2019** and must be accompanied by bid security, amounting to a minimum amount as specified in table below, which shall be valid minimum up to **Sept 7, 2019**. Alternatively, bidders may submit their bid electronically through e-GP portal of Public Procurement Monitoring Office (PPMO), Web Site <http://www.bolpatra.gov.np> as specified in the Instruction to Bidders.
7. If bidder wishes to submit the Bid Security in the form of cash, bidder has to deposit cash in Deposit Dharauti Account No. 69CA501175524006 of Office of Budhiganga Rural Municipality, Morang at NIC asia, Biratnagar Branch and submit bank deposit voucher along with the bid.
