4. Pre-bid meeting shall be held at **Budhiganga Rural Municipal Executive Office, Hattimuda, Morang** at 2079/11/01 (13 February 2023) at 1 P.M.
5. Electronic bids must be submitted to the office **Budhiganga Rural Municipal Executive Office, Hattimuda, Morang** through PPMO website www.bolpatra.gov.np/egpon or before 12:00 noon on 2079/11/11 (23 February 2023). Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00 pm 2079/11/11 (23 February 2023) at the office of **Budhiganga Rural Municipal Executive Office, Hattimuda, Morang**. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format RS amount mentioned above, which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
